- a. Approval of Shared Ministry recommendation of team size, terms and process and clarification about announcements of Drew's duties – (Drew) postponed
  - Guy moved to approve the revision of the board policy as written by Drew Frantz (see below), Jodi seconded. Motion carried
    - 1. Shared Ministry Team (New language-first paragraph) The Shared Ministry Team will consist of four members plus the Minister. Members of the Shared Ministry Team should be members of the Fellowship, but not members of the Board of Trustees. The four members will normally serve overlapping two-year terms: two new members will be appointed each year and two members will rotate off. Members may, however, serve two consecutive terms with the approval of the Board. Shared Ministry Team members will be chosen evenly by the Minister and by the Board of Trustees, each year one new member chosen by the Minister and one by the Board.
  - ii. The request from Chris Bailey from the Shared Ministry Team regarding announcing Drew's duties was referred to the Worship Team.
- b. New UUFCM banner The banner is complete and ready for the January 17 MLK Day march!
- c. Follow-up from congregation survey about activities/events (Elaine and Drew) Elaine met with the Fellowship Life Coordinating Team to share the results, and it was determined that she would provide a follow-up survey with more specifics for some of the activities that had higher interest days and times. Drew will consider whether to offer something more spiritual (vespers, for example) with the worship team.
- d. REMIND follow-up Now that the sign-up for Remind is simply online, Laura McBride is willing to be the one to send out reminders when necessary.
- e. Finalize membership on the Nominating Committee (Guy) Guy announced that he yet needs to find someone to join Cynthia and himself on the committee.
- f. Plan for January 22 retreat and contacting all members
  - i. Norma and Guy shared the plans for the retreat.
  - ii. Board members will call/email a curated list of members to invite them to attend the Retreat.

- a. Decision regarding the rest of January worship services and meeting on January 23 (4th Sunday) regarding February services
  - Guy moved to accept the Coronavirus Task Force recommendation to not hold in-person services in January 2022, Stacey seconded. Motion carried
  - ii. Emergency board meeting scheduled for January 23, 2022 to decide on February services

- b. Youth RE request for planning for in-person RE classes in February

   Drew shared that they have put off the plan until March and that
   they will be bound by whatever guidelines the Fellowship has for
   Covid safety.
- c. Stewardship drive plan (Guy) postponed
- d. Review employee mid-year evaluations (Drew)
  - i. Kirsten's evaluation was excellent.
    - ii. Need to consider mentoring Jakobe to improve his performance
      - 1. Cynthia Damer will ask Carol Rard or Sally Armstrong (and others if need be) to assist with this.

#### e. DRE contract

- i. Guy moved to have an 18-month contract, for the first half \$16.25 per hour, then assuming satisfactory evaluation, for the second half of the contract the pay rate would be increasing to \$17.50, Jodi seconded. Motion carried.
- ii. Norma moved \$6300 for the budget for the Youth RE Director, Stacey seconded. Motion carried.
- f. MidAmerica Regional Assembly April 30 We will need to determine if we wish to send people to the virtual assembly once the registration cost has been announced.
- g. Revisit Edward Jones Calvert Fund decision (Guy)
  - i. Guy will research other brokerage possibilities other than Edward Jones that would save us money.
- h. Form bylaws revision committee Norma and Stacey will review the bylaws for any changes necessary for the annual meeting.

Once all three evaluations have been sent and shared (Board, Shared Ministry Team and Drew's self-evaluation), we will meet to discuss in the near future.
