11. Old business –

a. Dawn's sendoff went well although the video did not work past worship into the presentation of her gift. Vicki reported thus far we have collected enough to cover the cost of Dawn's gift plus \$157 cash which will put on a Visa Card. There may be more

to come. – (ultimately Congregation donations covered the gift and a \$500 gift card.) b. Plans to help the congregation understand interim ministry will be the topic for the Fellowship Life meeting on July 28 at 11:45 AM. c. Ricky will produce a reimbursement form that includes our address and tax id number to be used along with receipts to submit requests for reimbursement. She will report all line items at the November meeting each year as well as at year's end.
