To Whom It May Concern:

The Unitarian Universalist Fellowship of Central Michigan ((UUFCM) has been working for over a year to become a Welcoming Congregation, an official designation granted by the Unitarian Universalist Association to those UU congregations who have through various actions, both internally and in the community, worked to educate themselves and become an explicitly welcoming congregation for GLBT people. As part of our process, we have become aware that Mt. Pleasant does not have any anti-discrimination ordinance at all, and even its Policy on Civil Rights and Employment Practices (1975), is limited to only public employees.

We are interested in changing this, and to that end we have invited Equality Michigan (a state organization that works to achieve full equality and respect for all people in Michigan regardless of sexual orientation, gender identity and gender expression) to come to Mt. Pleasant to present an informational meeting that would provide direction for this effort.

Our goal is to have the City Commission pass an anti-discrimination ordinance for the city of Mt. Pleasant and assure that it is also inclusive of sexual orientation, gender identity and gender expression. With the expertise that Equality Michigan brings, they would help us develop appropriate language for such an ordinance, help us develop a plan to propose this ordinance, and help us to guide our efforts to successful completion.

We have invited a number of groups who have been working to make Mt. Pleasant a more inclusive community to join in this important effort. At this point, they are: Mt. Pleasant Area Diversity Group, the Human Rights Commission of Isabella County, the Office of Gay and Lesbian Programs at CMU, SPECTRUM (the student Gay/Straight Alliance at CMU), PFLAG, the Mid-Michigan Interfaith Coalition, the Office of Institutional Diversity at CMU, and the Michigan Roundtable.

We are inviting you – any and all members of your group – to come to this meeting with Equality Michigan on Monday, April 25, at 7:00 pm at the Unitarian Universalist Fellowship of Central Michigan at 319 S University Avenue (corner of University and Wisconsin).
